336th District Court Felony Dispositions for September, 2015

Richard Glaser, Criminal District Attorney, released a list of people who entered into plea agreements with his office during the September dockets before Judge Laurine Blake of the 336th District Court of Fannin County. The following individuals either entered guilty pleas and accepted responsibility for their conduct without further court action or their cases went to trial and a Fannin County Jury rendered the verdict and sentence indicated.

Holly Amber Adams, 34, of Bonham - pleaded guilty to the 3rd Degree Felony offense of DRIVING WHILE INTOXICATED 3RD OR MORE. Adams was convicted and sentenced to a term of 4 years incarceration in the Texas Department of Criminal Justice — Institutional Division and assessed \$314 court costs and \$80 restitution.

Theresa Shelley Barzee, 38, of Leonard - pleaded guilty to the State Jail Felony offense of **POSS** (*Possession*) **CS** (*Controlled Substance*) **PG 1** (*Penalty Group 1*) **<1G** (*Less Than 1 Gram*). Barzee was placed on Deferred Adjudication Community Supervision for a period of 4 years and assessed a \$500 fine, \$329 court costs and \$180 restitution.

Bryan Bradley, 39, of Bonham - pleaded guilty to the 2nd Degree Felony offense of **BURGLARY OF A HABITATION**. Bradley was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,500 fine, \$269 court costs and \$110 restitution. After sentencing Bradley, the court suspended his sentence and placed him on community supervision for a period of 10 years.

Jeffery Case Gonzales, 28, of Bonham - pleaded guilty to the 3rd Degree Felony offense of INTOXICATION ASSAULT W/VEHICLE SBI. Gonzales was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs and \$396,236.21 restitution. After sentencing Gonzales, the court suspended his sentence and placed him on community supervision for a period of 10 years.

Ivan Dewey Harold Metzke, Jr., 26, of Pecan Gap - pleaded guilty to the State Jail Felony of **POSS CS PG 1** <**1G**. Metzke was convicted and sentenced to a term of 16 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$180 restitution.

Jonathon Scott Parker, 20, of Bonham - pleaded true to the allegations contained in the State's Motion Adjudicating Guilt. Parker was convicted and sentenced to a term of 15 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,000 fine and \$304 court costs for the State Jail Felony offense of **UNAUTHORIZED USE OF VEHICLE** committed on or about September 14, 2014.

Glen Wilson Pearson, 60, of Plano - pleaded true to the allegations contained in the State's Motion Revoking Community Supervision. Pearson was convicted and sentenced to a term of 12 months incarceration in the Fannin County Jail and assessed a \$955 fine, \$339 court costs and \$77 restitution for the *lesser included* Class A Misdemeanor offense of **DRIVING WHILE INTOXICATED 2ND** committed on or about October 19, 2013.

William Russell Shirer, 28, of Leonard - pleaded true to the allegations contained in the State's Motion Revoking Community Supervision. Shirer was convicted and sentenced to a term of 18 months incarceration in the Texas Department of Criminal Justice — State Jail Division and assessed a \$1,250 fine and \$191 court costs for the State Jail Felony offense of EVADING ARREST DETENTION W/PREVIOUS CONVICTION committed on or about September 27, 2013.

Rebecca Sulley, 20, of Ft. Worth - pleaded guilty to the State Jail Felony offense of **FORGERY FINANCIAL INSTRUMENT.** Sulley was placed on Deferred Adjudication Community Supervision for a period of 8 months and assessed \$254 court costs and \$979.48 restitution.
