Grand Jury Hears Multiple Drug Charges

Criminal District Attorney Richard Glaser reports that the Fannin County Grand Jury heard eighteen (18) cases presented for its consideration during their December 17 session. Eighteen (18) cases were true billed and indictments filed with the District Clerk, Nancy Young. Once filed, those cases will be promptly scheduled for a first appearance before Judge Laurine Blake of the 336th District Court. The Fannin County Grand Jury returned 393 true bills of indictment in 2015.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
