### **Fannin County Citizens Hear About Sexual Assaults, Burglaries and Forgeries During Grand Jury Session**

Criminal District Attorney Richard Glaser reports that on Thursday, February 18, 2016, the Grand Jury met to consider thirty-three (33) cases. Thirty-two (32) cases were True Billed or indicted and filed with the District Clerk. The Fannin County Grand Jury has returned 63 true bills of indictment so far in 2016.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
