336th District Court Felony Dispositions for January, 2016

Richard Glaser, Criminal District Attorney, released a list of people who entered into plea agreements with his office during the January dockets before Judge Laurine Blake of the 336th District Court of Fannin County. The following individuals either entered guilty pleas and accepted responsibility for their conduct without further court action or their cases went to trial and a Fannin County Jury rendered the verdict and sentence indicated.

Allecia Ann Booher, 52, of Leonard - pleaded guilty to *fifteen (15)* State Jail Felony offenses of **TAMPER W/GOVERNMENT RECORD DEFRAUD/HARM**. Prior to her plea, Booher paid in full the monies (\$80,000) taken in these cases to the city of Leonard. Booher was convicted and sentenced to serve a term of 9 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$319 court costs.

Allecia Ann Booher, 52, of Leonard - pleaded guilty to *twenty (20)* State Jail Felony offenses of **CREDIT CARD OR DEBIT CARD ABUSE**. Booher was convicted and sentenced to serve a term of 9 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$319 court costs.

Allecia Ann Booher, 52, of Leonard - pleaded guilty to the State Jail Felony offense of **SECURE EXECUTION DOC DECPT >=\$1,500<\$20,000**. Booher was convicted and sentenced to serve a term of 9 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$319 court costs.

Allecia Ann Booher, 52, of Leonard - pleaded guilty to the State Jail Felony offense of **FORGERY FINANCIAL INSTRUMENT**. Booher was convicted and sentenced to serve a term of 9 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$319 court costs.

Allecia Ann Booher, 52, of Leonard - pleaded guilty to the 2nd Degree Felony offense of **THEFT OF PROPERTY >=\$20,000<\$100,000 ENHANCED**. Booher was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed \$319 court costs and \$80,000 restitution. After sentencing Booher, the court suspended her sentence and placed her on community supervision for a period of 7 years.

Allecia Ann Booher, 52, of Leonard - pleaded guilty to the 3rd Degree Felony offense of **THEFT OF PROPERTY >=\$1,500<\$20,000 ENHANCED**. Booher was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$319 court costs. After sentencing Booher, the court suspended her sentence and placed her on community supervision for a period of 7 years.

Kristy Lynn Brese, 33, of Durant, Oklahoma - pleaded true to the allegations contained in the State's Motion to Revoke Community Supervision. Brese was convicted and sentenced to serve a term of 12 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,475 fine, \$414 court costs and \$82 restitution for the State Jail Felony offense of **POSS (POSSESSION) CS (CONTROLLED SUBSTANCE) PG (PENALTY GROUP 1 <1G (LESS THAN ONE GRAM))** committed on or about December 18, 2012.

Dustin Keith Bryan, 26, of Sherman - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Bryan was convicted and sentenced to serve a term of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,680 fine and \$319 court costs for the 3rd Degree Felony offense of **ASSAULT FAM/HOUSE MEM IMPEDE BREATH/CIRCULATION** committed on or about December 29, 2013.

Dustin Keith Bryan, 26, of Sherman - pleaded guilty to the State Jail Felony offense of **THEFT OF PROPERTY >=\$1,500<\$20,000**. Bryan was convicted and sentenced to serve a term of 12 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$254 court costs and \$850 restitution.

Melissa Andrea Cannon, 32, of Telephone - pleaded guilty to the State Jail Felony offense of **POSS CS PG 1 <1G**. Cannon was convicted and sentenced to serve a term of 12 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$254 court costs and \$180 restitution.

Cassidy Carpenter, 28, of Kaufman - pleaded guilty to the State Jail Felony offense of **POSS CS PG 1 <1G**. Carpenter was placed on Deferred Adjudication Community Supervision for a period of 5 years, assessed \$329 court costs and \$180 restitution.

Michael Anthony Day, 62, of Bonham – pleaded guilty to the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED 3RD OR MORE**. Day was convicted and sentenced to a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,000 fine, \$314 court costs and \$100 restitution. After sentencing Day, the court suspended his sentence and placed him on community supervision for a period of 5 years.

Michael Anthony Day, 62, of Bonham – pleaded guilty to the 3rd Degree Felony offense of **EVADING ARREST DETENTION W/VEHICLE**. Day was convicted and sentenced to a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$249 court costs. After sentencing Day, the court suspended his sentence and placed him on community supervision for a period of 5 years.

Julie Ann Fields, 52, of Bonham - pleaded guilty to the State Jail Felony offense of **POSS CS PG 1 <1G**. Fields was placed on Deferred Adjudication Community Supervision for a period of 4 years, assessed a \$500 fine, \$314 court costs and \$180 restitution.

Michael Kirk Holloway, 69, of Ladonia – pleaded guilty to the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED 3RD OR MORE – ENHANCED**. Holloway was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,000 fine, \$374 court costs and \$100 restitution. After sentencing Holloway, the court suspended his sentence and placed him on community supervision for a period of 10 years.

Michael Kirk Holloway, 69, of Ladonia – pleaded guilty to the 3rd Degree Felony offense of **ESCAPE WHILE ARRESTED/CONFINED FELONY**. Holloway was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$254 court costs. After sentencing Holloway, the court suspended his sentence and placed him on community supervision for a period of 10 years.

Michael Paul Lavender, 29, of Jacksonville, Florida - pleaded guilty to the State Jail Felony offense of **POSS CS PG 1 <1G**. Lavender was placed on Deferred Adjudication Community Supervision for a period of 5 years, assessed a \$750 fine, \$314 court costs and \$180 restitution.

Michelle Renea Sewell, 51, of Bonham - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Sewell was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,500 fine and \$249 court costs for the 2nd Degree Felony offense of **AGG ASSAULT W/DEADLY WEAPONG – ENHANCED** committed on or about October 15, 2014.

Anthony David Smith, 56, of Dallas – pleaded not guilty to the 2nd Degree Felony Offense of **INDECENCY W/CHILD SEXUAL CONTACT**. Smith and was FOUND GUILTY BY A JURY and punishment was assessed by the Court. Smith was sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and he was assessed \$724 court costs.

Tommy Don Thompson, 37, of Trenton – pleaded guilty to the 3rd Degree Felony offense of **VIOLATION OF BOND/PROTECTIVE ORDER 2+ TIMES W/I 12 MONTHS**. Thompson was placed on Deferred Adjudication Community Supervision for a period of 8 years and assessed a \$2,500 fine and \$254 court costs.

Tommy Don Thompson, 37, of Trenton – pleaded guilty to the State Jail Felony offense of **INJURY CHILD/ELDERLY/DISABLED RECKLESS BODILY INJURY**. Thompson was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed \$254 court costs.

Brandi York, 32, of Bonham – pleaded guilty to the State Jail Felony offense of **THEFT OF PROPERTY >=\$1,500<\$20,000**. York was placed on Deferred Adjudication Community Supervision for a period of 3 years and assessed \$269 court costs and \$1,500 restitution.

Robert Luis Williams-Vazquez, 25, of Pineland – pleaded guilty to the 3rd Degree Felony offense of **BAIL JUMPING AND FAIL TO APPEAR FELONY**. Williams-Vazquez was placed on Deferred Adjudication Community Supervision for a period of 7 years and assessed \$254 court costs.

Robert Luis Williams-Vazquez, 25, of Pineland – pleaded guilty to the State Jail Felony offense of **POSS CS PG 1 <1G**. Williams-Vazquez was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed a \$3,000 fine, \$309 court costs and \$180 restitution.

Wesley Thomas Whitlock, 41, of Denison - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Whitlock was convicted and sentenced to serve a term of 8 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$2,500 fine, \$638 court costs and \$7,300.55 restitution for the 2nd Degree Felony offense of **SEXUAL ASSAULT OF A CHILD** committed on or about June 15, 2002.

Jonathan Eugene Wright, 29, of Leonard - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Wright was convicted and sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$2,000 fine, \$314 court costs and \$140 restitution for the 2nd Degree Felony offense of **MAN DEL CS PG 1 >=1G<4G** committed on or about March 27, 2014.
