Drug Cases Dominate Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, August 18, 2016, the Grand Jury met to review twenty-two (22) cases presented for their consideration. The Grand Jury returned twenty-two (22) true bills or indictments listed below. The recently impaneled Fannin County Grand Jury was presented with more cases from the recent drug bust operation. The Fannin County Grand Jury has returned 277 true bills of indictment so far in 2016.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
