336th District Court Felony Dispositions for July, 2016

Richard Glaser, Criminal District Attorney, released a list of people who entered into plea agreements with his office during the July dockets before Judge Laurine Blake of the 336th District Court of Fannin County. The following individuals either entered guilty pleas and accepted responsibility for their conduct without further court action or their cases went to trial and a Fannin County Jury rendered the verdict and sentence indicated. For the month of July, there were 67 new cases indicted.

Candice Nicole Brooks, 31, of Bonham - pleaded guilty to the State Jail Felony offense of **POSS (POSSESSION) CS (CONTROLLED SUBSTANCE) PG (PENALTY GROUP) 1 <1G (LESS THAN ONE GRAM)**. Brooks was placed on Deferred Adjudication Community Supervision for a period of 5 years, assessed a \$1,000 fine, \$364 court costs and \$180 restitution. As a condition of probation, Brooks was sent to SAFPF.

Candice Nicole Brooks, 31, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **BAIL JUMPING AND FAIL TO APPEAR FELONY**. Brooks was placed on Deferred Adjudication Community Supervision for a period of 8 years and assessed \$304 court costs. As a condition of probation, Brooks was sent to SAFPF.

SAFPF (Substance Abuse Felony Punishment Facility) is an intensive 6-9 month program in a SAFPF Unit for offenders who are sentenced by the Judge who are chemically dependent as shown by an accepted substance abuse screening instrument. Offenders who successfully complete the unit program must transition to an approved Texas Department of Criminal Justice residential facility, or, if they have a good home plan, they are released to the 4C program. From there, they start a supportive outpatient program that is approved by TDCJ.

Courtney Leigh Butner, 26, of Bonham - pleaded true to the allegations contained in the State's Motion Adjudicating Guilt. Butner was convicted and sentenced to serve a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$600 fine, \$104 court costs and \$29 restitution for the State Jail Felony offense of **DELIVERY OF MARIJUANA >1/4OZ <=5LBS** committed on or about August 3, 2012. After sentencing Butner, the court suspended her sentence and placed her on community supervision for a period of 5 years.

Courtney Leigh Butner, 26, of Bonham - pleaded true to the allegations contained in the State's Motion Adjudicating Guilt. Butner was convicted and sentenced to serve a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$279 court costs for the State Jail Felony offense of **DELIVERY OF MARIJUANA >1/4OZ <=5LBS** committed on or about August 8, 2012. After sentencing Butner, the court suspended her sentence and placed her on community supervision for a period of 5 years.

Courtney Leigh Butner, 26, of Bonham - pleaded true to the allegations contained in the State's Motion Adjudicating Guilt. Butner was convicted and sentenced to serve a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$279 court costs for the State Jail Felony offense of **POSSESSION OF MARIJUANA >4OZ <=5LBS** committed on or about August 10, 2012. After sentencing Butner, the court suspended her sentence and placed her on community supervision for a period of 5 years. Butner was referred to the Fannin County Drug Court program of intense but personalized supervision.

Courtney Leigh Butner, 26, of Bonham - pleaded guilty to *two* 3rd Degree Felony offenses of **FORGERY OF A FINANCIAL INSTRUMENT ELDERLY**. Butner was convicted and sentenced to a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed \$508 court costs and \$400 restitution. After sentencing Butner, the court suspended her sentence and placed her on community supervision for a period of 5 years in each case.

Quentin Carpenter, 45, of Honey Grove - pleaded guilty to the State Jail Felony offense of **UNAUTHORIZED USE OF VEHICLE**. Carpenter was placed on Deferred Adjudication Community Supervision for a period of 3 years and assessed \$254 court costs.

Rickey Dean Gibson, Jr., 35, of Bonham - pleaded guilty to *two lesser included* 2nd Degree Felony offenses of **ROBBERY**. Gibson was convicted and sentenced to serve a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$508 court costs and \$400 restitution. The sentences for Gibson shall run concurrently.

Raul Hernandez Hackett, 39, of Bonham - pleaded guilty to the State Jail Felony offense of **UNAUTHORIZED USE OF VEHICLE**. Hackett was placed on Deferred Adjudication Community Supervision for a period of 4 years and assessed a \$750 fine and \$259 court costs.

Jimmy Dale Hall, Jr., 37, of Bonham - pleaded guilty to the *lesser included* 3rd Degree Felony offense of **POSS CS PG 1 >=1G<4G**. Hall was convicted and sentenced to a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division, and assessed \$364 court costs and \$180 restitution.

Phillip Houser, 51, of Leonard - pleaded guilty to the 3rd Degree Felony offense of **PROHIBITED SUBSTANCE/ITEM IN CORRECTIONAL FACILITY**. Houser was placed on Deferred Adjudication Community Supervision for a period of 8 years and assessed \$249 court costs and \$180 restitution. Houser was referred to the Fannin County Drug Court program of intense but personalized supervision.

Phillip Houser, 51, of Leonard - pleaded guilty to the 3rd Degree Felony offense of **POSSESSION CS PG 1 <1G DRUG FREE ZONE**. Houser was placed on Deferred Adjudication Community Supervision for a period of 8 years and assessed a \$750 fine, \$309 court costs and \$180 restitution. Houser was referred to the Fannin County Drug Court program of intense but personalized supervision.

Rachel Anne Kimball, 21, of Honey Grove - pleaded true to the allegations contained in the State's Motion Adjudicating Guilt. Kimball was convicted and sentenced to serve a term of 60 days in the County Jail and assessed a \$500 fine and \$249 court costs for the *lesser included* Class A Misdemeanor offense of **TERRORISTIC THREAT AGAINST A PUBLIC SERVANT** committed on or about September 21, 2011.

Shannon Renae King, 33, of Ladonia - pleaded guilty to the 1st Degree Felony offense of **POSS CS PG 1 >=4G<200G DRUG FREE ZONE**. King was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, and assessed \$314 court costs and \$180 restitution.

Shannon Renae King, 33, of Ladonia - pleaded guilty to the 1st Degree Felony offense of **MAN DEL CS PG 1 <1G DRUG FREE ZONE**. King was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, and assessed \$314 court costs and \$180 restitution. The sentences for King shall run concurrently.

Nickey Lynn Montgomery, 33, of Sherman - pleaded guilty to the 2nd Degree Felony offense of **BURGLARY OF A HABITATION – ENHANCED**. Montgomery was placed on Deferred Adjudication Community Supervision for a period of 7 years and assessed \$249 court costs and \$3,098 restitution.

Jeffery Dean Parsons, 43, of Leonard - pleaded guilty to the 3rd Degree Felony offense of **STALKING**. Parsons was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed \$314 court costs.

Kerry Ray Payne, 36, of Ector - pleaded guilty to the 3rd Degree Felony offense of **VIOLATION OF BOND/PROTECTIVE ORDER 2+ TIMES W/I 12 MONTHS**. Payne was convicted and sentenced to a term of 8 years incarceration in the Texas Department of Criminal Justice – Institutional Division, and assessed \$254 court costs.

Kerry Ray Payne, 36, of Ector - pleaded true to the allegations contained in the State’s Motion Revoking Community Supervision. Payne was convicted and sentenced to serve a term of 8 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,780 fine and \$379 court costs for the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED 3RD OR MORE** committed on or about July 21, 2013. The sentences for Payne shall run concurrently.

Shae Lynn Prescott, 34, of Bonham - pleaded guilty to the *lesser included* Class B Misdemeanor offense of **CRIMINAL TRESPASS**. Prescott was convicted and sentenced to 180 days in County Jail and assessed \$264 court costs.

Michael Lynn Price, 39, of Leonard - pleaded true to the allegations contained in the State’s Motion Revoking Community Supervision. Price was convicted and sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,976 fine and \$249 court costs for the State Jail Felony offense of **BURGLARY OF BUILDING – ENHANCED** committed on or about January 14, 2015.

Jose Arnuldo Rodriguez, 25, of Bonham - pleaded guilty to *three* State Jail Felony offenses of **DRIVING WHILE INTOXICATED W/CHILD UNDER 15 YEARS OF AGE**. Rodriguez was convicted and sentenced to a term of 18 months incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$1,500 fine (probated \$1,000) and \$987 court costs. After sentencing Rodriguez, the court suspended his sentence and placed him on community supervision for a period of 5 years in each case.

Christy Speegle, 33, of Gainesville - pleaded guilty to the 3rd Degree Felony offense of **PROHIBITED SUBSTANCE/ITEM IN CORRECTIONAL FACILITY**. Speegle was placed on Deferred Adjudication Community Supervision for a period of 4 years and assessed a \$300 fine and \$249 court costs.

Shayna Brook Sutton, 20, of Bonham - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Sutton was placed on Deferred Adjudication Community Supervision for a period of 3 years and assessed a \$500 fine, \$329 court costs and \$180 restitution.

James Brody Wade, 20, of Bailey - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **ASSAULT CAUSES BODILY INJURY**. Wade was convicted and sentenced to 5 days in County Jail.

Jack Percy Young, III, 26, of Sherman - pleaded true to the allegations contained in *two* State’s Motion Adjudicating Guilt. Young was convicted and sentenced to serve a term of 18 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,225 fine, \$628 court costs and \$140 restitution for the *two* State Jail Felony offenses of **POSSESSION CS PG 3 <28G DRUG FREE ZONE** committed on or about July 19, 2013.
