### Joint Efforts of Several Law Enforcement Agencies Result in Hearing Multiple Drug Charges

Criminal District Attorney Richard Glaser reports that on Thursday, July 28, the newly impaneled Grand Jury for the July Term convened for their first formal session. At that initial session and after some brief instructions in the workings of a Grand Jury, sixty-seven (67) cases were presented resulting in sixty-seven (67) True Bills of indictment. Many of the charges were the result of the recent undercover operations involving multiple law enforcement agencies. The Fannin County Grand Jury has returned 255 true bills of indictment so far in 2016.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
