336th District Court Felony Dispositions for June, 2016

Richard Glaser, Criminal District Attorney, released a list of people who entered into plea agreements with his office during the June dockets before Judge Laurine Blake of the 336th District Court of Fannin County. The following individuals either entered guilty pleas and accepted responsibility for their conduct without further court action or their cases went to trial and a Fannin County Jury rendered the verdict and sentence indicated. For the month of June, there were 26 new cases indicated.

Seven of the cases disposed of involved felony driving while intoxicated. The District Attorney's Office approach to this severe problem continues to be one of no tolerance for DWIs. Our no refusal program is in effect 24/7. Of the seven cases finalized this month, two defendants were sent to prison for either 7 or 12 years, two were sent to SAFPF (*Substance Abuse Felony Punishment Facility*) and the other three were referred to Fannin County's Drug Court Program. This no nonsense approach should be a warning to anyone before they choose to drink and drive in Fannin County.

James Edward Aaron, 58, of Bonham - pleaded guilty to the 3rd Degree Felony offense of EVADING ARREST DETENTION W/VEHICLE. Aaron was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, and assessed \$319 court costs.

James Edward Aaron, 58, of Bonham - pleaded guilty to the 2nd Degree Felony offense of POSS (POSSESSION) CS (CONTROLLED SUBSTANCE) PG (PENALTY GROUP) 1 >=4G (GREATER OR EQUAL TO FOUR GRAMS) <200G (LESS THAN 200 GRAMS) - ENHANCED. Aaron was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, and assessed \$379 court costs and \$180 restitution. The above sentences for James Edward Aaron shall run concurrently.

Lucas Allen Alford, 32, of Whitewright - pleaded guilty to the State Jail Felony offense of **DRIVING WHILE INTOXICATED W/CHILD UNDER 15 YEARS OF AGE.** Alford was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$500 fine, \$379 court costs and \$100 restitution. After sentencing Alford, the court suspended his sentence and placed him on community supervision for a period of 5 years. As a condition of probation, Alford was sent to SAFPF.

SAFPF (Substance Abuse Felony Punishment Facility) is an intensive 6-9 month program in a SAFPF Unit for offenders who are sentenced by the Judge who are chemically dependent as shown by an accepted substance abuse screening instrument. Offenders who successfully complete the unit program must transition to an approved Texas Department of Criminal Justice residential facility, or, if they have a good home plan, they are released to the 4C program. From there, they start a supportive outpatient program that is approved by TDCJ.

Gerald Miles Craven, III, 35, of Ravenna - pleaded true to the allegations contained in the State's Motion Revoking Community Supervision. Craven was convicted and sentenced to serve a term of 7 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$2,000 fine, \$374 court costs and \$140 restitution for the 3rd Degree Felony offense of DRIVING WHILE INTOXICATED 3RD OR MORE committed on or about April 9, 2011.

Darin Lynn Daniel, 43, of Bonham - pleaded guilty to the 3rd Degree Felony offense of DRIVING WHILE INTOXICATED 3RD OR MORE. Daniel was convicted and sentenced to a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed a \$1,000 fine and \$329 court costs. After sentencing Daniel, the court suspended his sentence and placed him on community

supervision for a period of 5 years. Daniel was referred to the Fannin County Drug Court program of intense but personalized supervision.

Johnny Barrera Delatorre, 61, of Bonham - pleaded guilty to the 3rd Degree Felony offense of DRIVING WHILE INTOXICATED 3RD OR MORE – ENHANCED. Delatorre was convicted and sentenced to serve a term of 12 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs and \$100 restitution.

Patrick Holmes, 57, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED 3RD OR MORE.** Holmes was convicted and sentenced to a term of 8 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed a \$1,000 fine, \$379 court costs and \$100 restitution. After sentencing Holmes, the court suspended his sentence and placed him on community supervision for a period of 8 years. Holmes was referred to the Fannin County Drug Court program of intense but personalized supervision.

Michael Kay, 35, of Garland - pleaded guilty to the State Jail Felony offense of **UNAUTHORIZED USE OF VEHICLE.** Kay was convicted and sentenced to a term of 12 months incarceration in the Texas Department of Criminal Justice – State Jail Division, and assessed \$254 court costs.

Lynda Doyle Kaylor, 59, of Trenton - pleaded guilty to the State Jail Felony offense of **POSS CS PG 1 <1G.** Kaylor was placed on Deferred Adjudication Community Supervision for a period of 5 years, assessed a \$1,000 fine, \$379 court costs and \$180 restitution.

Cynthia Beth Lindblad, 39, of Garland - pleaded guilty to the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED 3RD OR MORE.** Lindblad was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed \$379 court costs and \$7,444.10 restitution. After sentencing Lindblad, the court suspended her sentence and placed her on community supervision for a period of 10 years. As a condition of probation, Lindblad was sent to SAFPF.

Cynthia Beth Lindblad, 39, of Garland - pleaded guilty to the 3rd Degree Felony offense of **BAIL JUMPING AND FAIL TO APPEAR FELONY.** Lindblad was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed \$304 court costs. As a condition of probation, Lindblad was sent to SAFPF.

Leslie Michelle Odom, 29, of Ivanhoe - pleaded guilty to the 2nd Degree Felony offense of **BURGLARY OF A HABITATION.** Odom was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed a \$1,000 fine and \$254 court costs.

Ricky Mikel Stapp, 62, of Bonham - pleaded guilty to the State Jail Felony offense of **MAN DEL CS PG 3/4 <28G.** Stapp was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed a \$1,000 fine, \$329 court costs and \$180 restitution.

Bryan Jay Thomas, 35, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **EVADING ARREST DETENTION W/VEHICLE.** Thomas was placed on Deferred Adjudication Community Supervision for a period of 8 years and assessed a \$1,500 fine, \$254 court costs and \$180 restitution.

Dann Burch Thompson, 61, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED 3RD OR MORE.** Thompson was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed a \$2,000 fine and \$314 court costs. After sentencing Thompson, the court suspended his sentence and placed him on

community supervision for a period of 10 years. Thompson was referred to the Fannin County Drug Court program of intense but personalized supervision.

Tina Wallis, 34, of Gainsville - pleaded guilty to the 3rd Degree Felony offense of **PROHIBITED SUBSTANCE/ITEM IN CORRECTIONAL FACILITY.** Wallis was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed a \$750 fine, \$249 court costs and \$180 restitution.

Rhea Kaitlyn Wright, 26, of Bonham - pleaded true to the allegations contained in the State's Motion Revoking Community Supervision. Wright was convicted and sentenced to serve a term of 8 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$2,000 fine, \$299 court costs and \$90 restitution for the 2nd Degree Felony offense of BURGLARY OF A HABITATION committed on or about March 15, 2012.

Rhea Kaitlyn Wright, 26, of Bonham - pleaded true to the allegations contained in the State's Motion Revoking Community Supervision. Wright was convicted and sentenced to serve a term of 8 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$2,000 fine, \$359 court costs and \$140 restitution for the 3rd Degree Felony offense of POSS CS PG 1 >=1G<4G committed on or about May 6, 2012.
