Drug and Alcohol Charges Prevail at Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, September 22, 2016, the Grand Jury met to review forty-eight (48) cases presented for their consideration. The Grand Jury returned forty-eight (48) true bills or indictments listed below. Drug and alcohol charges accounted for many of the new felony charges filed. The Fannin County Grand Jury has returned 325 true bills of indictment so far in 2016.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
