### **Adopt-A-Cop Theft Charges and Official Oppression Against Former Police Chief Dominate Fannin County Grand Jury Session**

Criminal District Attorney Richard Glaser reports that on Thursday, November 17, 2016, the Grand Jury met in a lengthy session to review evidence in twenty-eight (28) cases presented for their consideration. The Grand Jury returned twenty-seven (27) true bills or indictments filed with the District Clerk, Nancy Young. Once filed, those cases will be promptly scheduled for a first appearance before Judge Laurine Blake of the 336<sup>th</sup> District Court listed below. Theft and drug charges accounted for over half of the new felony charges filed. The Fannin County Grand Jury has returned 388 true bills of indictment so far in 2016.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
