Drugs, Sex and Drive-by-Shootings Dominate Fannin County Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, October 20, 2016, the Grand Jury met to review evidence in thirty-eight (38) cases presented for their consideration. The Grand Jury returned thirty-six (36) true bills or indictments listed below. Two (2) cases were passed for further action next session. Drugs and theft charges accounted for over half of the new felony charges filed. The Fannin County Grand Jury has returned 361 true bills of indictment so far in 2016.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
