336th District Court Felony Dispositions for October, 2016

Richard Glaser, Criminal District Attorney, released a list of people who entered into plea agreements with his office during the October dockets before Judge Laurine Blake of the 336th District Court of Fannin County. The following individuals either entered guilty pleas and accepted responsibility for their conduct without further court action or their cases went to trial and a Fannin County Jury rendered the verdict and sentence indicated.

Jared Ryan Ball, 31, of Bells - pleaded guilty to the 3rd Degree Felony offense of **MAN (MANUFACTURE) DEL (DELIVERY) CS (CONTROLLED SUBSTANCE) PG (PENALTY GROUP) 1 <1G (LESS THAN ONE GRAM) DRUG FREE ZONE**. Ball was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs and \$180 restitution.

Jared Ryan Ball, 31, of Bells - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Ball was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,510 fine, \$379 court costs and \$140 restitution for the 3rd Degree Felony offense of **MAN DEL CS PG 1 <1G DRUG FREE ZONE** committed on or about September 23, 2014.

Joshua Michael Bell, 33, of Pottsboro - pleaded guilty to the 3rd Degree Felony offense of **PROHIBITED SUBSTANCE CORRECTION FACILITY-ATTEMPT—ENHANCED**. Bell was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed a \$3,500 fine, \$319 court costs and \$180 restitution. After sentencing Bell, the court suspended his sentence and placed him on community supervision for a period of 10 years.

Krystal Michelle Bryant, 27, of Leonard - pleaded guilty to the 2nd Degree Felony offense of **POSSESSION CS PG 1 >=4G<200G**. Bryant was placed on Deferred Adjudication Community Supervision for a period of 8 years and assessed a \$1,000 fine, \$424 court costs and \$180 restitution. As a condition of probation, Bryant was sent to SAFPF.

SAFPF (Substance Abuse Felony Punishment Facility) is an intensive 6-9 month program in a SAFPF Unit for offenders who are sentenced by the Judge who are chemically dependent as shown by an accepted substance abuse screening instrument. Offenders who successfully complete the unit program must transition to an approved Texas Department of Criminal Justice residential facility, or, if they have a good home plan, they are released to the 4C program. From there, they start a supportive outpatient program that is approved by TDCJ.

Harold Douglas Eckstein, 68, of Victoria - pleaded guilty to the State Jail Felony offense of **BURGLARY OF BUILDING—ENHANCED**. Eckstein was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$254 court costs.

Jeramiah L. Fields, 39, of Bonham - pleaded guilty to the State Jail Felony offense of **DRIVING WHILE INTOXICATED W/CHILD UNDER 15 YOA**. Fields was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$750 fine and \$314 court costs. After sentencing Fields, the court suspended his sentence and placed him on community supervision for a period of 5 years. As a condition of probation, Fields was sent to SAFPF.

Jeremiah L. Fields, 39, of Bonham - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **ASSAULT CAUSES BODILY INJURY**. Fields was convicted and sentenced to serve a term of 57 days County Jail and assessed \$314 court costs.

Rene A. Gray, 40, of Savoy - pleaded guilty to the 2nd Degree Felony offense of **MAN DEL CS PG 1 >=1G<4G DRUG FREE ZONE**. Gray was convicted and sentenced to serve a term of 15 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$374 court costs and \$180 restitution.

Rene A. Gray, 40, of Savoy - pleaded guilty to the 2nd Degree Felony offense of **MAN DEL CS PG 1 >=1G<4G**. Gray was convicted and sentenced to serve a term of 15 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$374 court costs and \$180 restitution.

Rene A. Gray, 40, of Savoy - pleaded guilty to *two* State Jail Felony offenses of **MAN DEL CS PG 1 <1G**. Gray was convicted and sentenced to serve a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$753 court costs and \$360 restitution.

Misty Michelle Hangaman, 44, of Dodd City - pleaded guilty to *two* 3rd Degree Felony offenses of **MAN DEL CS PG 1 <1G DRUG FREE ZONE**. Hangaman was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed a \$1,500 fine, \$628 court costs and \$360 restitution. After sentencing Hangaman, the court suspended her sentence and placed her on community supervision for a period of 10 years. Hangaman was referred to the Fannin County Drug Court program of intense but personalized supervision.

Melissa Kay Honeycutt, 35, of Bonham - pleaded guilty to *three* State Jail Felony offenses of **MAN DEL CS PG 1 <1G**. Honeycutt was convicted and sentenced to serve a term of 18 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$942 court costs and \$540 restitution.

Melissa Kay Honeycutt, 35, of Bonham - pleaded guilty to *two* State Jail Felony offenses of **ABANDON ENDANGER CHILD CRIMINAL NEGLIGENCE**. Honeycutt was convicted and sentenced to serve a term of 18 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$508 court costs.

Michael Paul Lavender, 29, of Jacksonville - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Lavender was convicted and sentenced to serve a term of 18 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$750 fine, \$314 court costs and \$180 restitution for the State Jail Felony offense of **POSSESSION CS PG 1 <1G** committed on or about August 30, 2015.

Sterling Lee, Jr., 40, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **UNLAWFUL POSSESSION FIREARM BY FELON**. Lee was placed on Deferred Adjudication Community Supervision for a period of 4 years and assessed a \$3,000 fine and \$269 court costs.

Larry Gene Lovell, 54, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED 3RD OR MORE**. Lovell was convicted and sentenced to serve a term of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$364 court costs and \$100 restitution.

John David Manning, 32, of Bonham - pleaded guilty to *two* State Jail Felony offense of **MAN DEL CS PG 1 <1G**. Manning was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$1,500 fine, \$628 court costs and \$360 restitution. After sentencing Manning, the court suspended his sentence and placed him on community supervision for a period of 5 years in each case.

Kathy Lynn Martinez, 53, of Bonham - pleaded guilty to the 2nd Degree Felony offense of **POSSESSION CS PG 1 >=4G<200G – ENHANCED**. Martinez was convicted and sentenced to serve a term of 7 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs.

Deontra Terrel Mason, 30, of Bonham - pleaded guilty to the 2nd Degree Felony offense of **POSSESSION CS PG 1 >=4G<200G – ENHANCED**. Mason was convicted and sentenced to serve a term of 12 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs and \$180 restitution.

Richard Lee Reunard, 50, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **EVADING ARREST DETENTION W/VEHICLE**. Reunard was convicted and sentenced to serve a term of 9 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$254 court costs.

Richard Lee Reunard, 50, of Bonham - pleaded guilty to the State Jail Felony offense of **MAN DEL CS PG 1 <1G**. Reunard was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$314 court costs and \$180 restitution.

Robert Lynn Roach, 55, of Bonham - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Roach was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$1,500 fine, \$329 court costs and \$180 restitution. After sentencing Roach, the court suspended his sentence and placed him on community supervision for a period of 5 years. Roach was referred to the Fannin County Drug Court program of intense but personalized supervision.

Shannon Lee Robinson, 48, of Bonham - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Robinson was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$750 fine, \$329 court costs and \$180 restitution. After sentencing Robinson, the court suspended her sentence and placed her on community supervision for a period of 5 years. Robinson was referred to the Fannin County Drug Court program of intense but personalized supervision.

Jose Rodriguez, 34, of Bonham - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Rodriguez was convicted and sentenced to serve a term of 10 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$314 court costs and \$180 restitution.

James Earl Ruyle, 48, of Ladonia - pleaded guilty to the 3rd Degree Felony offense of **UNLAWFUL POSSESSION OF FIREARM BY FELON**. Ruyle was convicted and sentenced to serve a term of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$254 court costs.

James Earl Ruyle, 48, of Ladonia - pleaded guilty to *seven* State Jail Felony offenses of **BURGLARY OF A BUILDING – ENHANCED**. Ruyle was convicted and sentenced to serve a term of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$1,778 court costs and \$55,653.14 restitution.

Roberta Coffey Starr, 63, of Paris - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Starr was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed a \$500 fine, \$379 court costs and \$180 restitution.

Susan Ray Thomas, 44, of Bonham - pleaded guilty to **two** State Jail Felony offenses of **POSSESSION CS PG 1 <1G**. Thomas was convicted and sentenced to serve a term of 180 days incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,000 fine, \$688 court costs and \$360 restitution.

Susan Ray Thomas, 44, of Bonham - pleaded guilty to the 2nd Degree Felony offense of **MAN DEL CS PG 1 >1G<4G**. Thomas was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed \$314 court costs and \$180 restitution.

Shelbi Laine Titsworth, 21, of Bonham - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Titsworth was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$750 fine, \$314 court costs and \$180 restitution. After sentencing Titsworth, the court suspended her sentence and placed her on community supervision for a period of 5 years. As a condition of probation, Titsworth was sent to SAFPF.

Joshua Virgil Eric Tommie, 24, of Princeton - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Tommie was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$750 fine, \$324 court costs and \$180 restitution. After sentencing Tommie, the court suspended his sentence and placed him on community supervision for a period of 4 years. Tommie was referred to the Fannin County Drug Court program of intense but personalized supervision.

John Phillips Trunzler, 25, of Bonham - pleaded guilty to the 2nd Degree Felony offense of **MAN DEL CS PG 1 >1G<4G**. Trunzler was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed a \$1,000 fine, \$314 court costs and \$180 restitution. As a condition of probation, Trunzler was sent to SAFPF.

John Phillips Trunzler, 25, of Bonham - pleaded guilty to the State Jail Felony offense of **ABANDON ENDANGER CHILD CRIMINAL NEGLIGENCE**. Trunzler was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed \$254 court costs.

Rusty Lee Yeley, 47, of Ector - pleaded guilty to the 2nd Degree Felony offense of **MAN DEL CS PG 1 >=1G<4G**. Yeley was convicted and sentenced to serve a term of 6 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs and \$180 restitution.
