336th District Court Felony Dispositions for September, 2016

Richard Glaser, Criminal District Attorney, released a list of people who entered into plea agreements with his office during the September dockets before Judge Laurine Blake of the 336th District Court of Fannin County. The following individuals either entered guilty pleas and accepted responsibility for their conduct without further court action or their cases went to trial and a Fannin County Jury rendered the verdict and sentence indicated.

Christie Zimmerman Kissinger, 51, of Bells – pleaded not guilty to the 3rd Degree Felony Offense of **THEFT OF PROPERTY \$1,500<\$20,000 ENH.** Kissinger was FOUND GUILTY BY A JURY and that same Jury rendered a sentence of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division, and she was assessed a \$5,000 fine and \$414 court costs.

Bobby Don Baldwin, 34, of Denison - pleaded guilty to the *lesser included* State Jail Felony offense of **BURGLARY OF BUILDING.** Baldwin was convicted and sentenced to serve a term of 9 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$254 court costs.

Donna Lee Bolf, 20, of Melissa - pleaded true to the allegations contained in the State’s Motion to Adjudicate Guilt. Bolf was convicted and sentenced to serve a term of 9 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,000 fine and \$498 court costs for *two* State Jail Felony offenses of **BURGLARY OF BUILDING** committed on or about September 16, 2015 and September 26, 2015.

Jeremiah Bragg, 45, of Savoy - pleaded guilty to the State Jail Felony offense of **THEFT OF PROPERTY <\$2,500 2/MORE PREVIOUS CONVICTIONS.** Bragg was convicted and sentenced to serve a term of 89 days incarceration in the Fannin County Jail and assessed \$314 court costs.

Teisha Ann Brewer, 35, of Bonham - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **HINDER APPREHENSION/PROSECUTION.** Brewer was convicted and sentenced to serve a term of 46 days incarceration in the Fannin County Jail and assessed \$249 court costs and a \$500 fine.

Candice Nicole Brooks, 31, of Bonham - pleaded guilty to the State Jail Felony offense of **MAN (MANUFACTURE) DEL (DELIVERY) CS (CONTROLLED SUBSTANCE) PG (PENALTY GROUP) 1 <1G (LESS THAN ONE GRAM).** Brooks was placed on Deferred Adjudication Community Supervision for a period of 5 years, assessed \$314 court costs and \$180 restitution. As a condition of probation, Brooks was sent to SAFPF.

SAFPF (Substance Abuse Felony Punishment Facility) is an intensive 6-9 month program in a SAFPF Unit for offenders who are sentenced by the Judge who are chemically dependent as shown by an accepted substance abuse screening instrument. Offenders who successfully complete the unit program must transition to an approved Texas Department of Criminal Justice residential facility, or, if they have a good home plan, they are released to the 4C program. From there, they start a supportive outpatient program that is approved by TDCJ.

David Andrew Bryson, 63, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **ASSAULT FAMILY/HOUSEHOLD MEMBER W/PREVIOUS CONVICTION—ENHANCED.** Bryson was convicted and sentenced to serve a term of 2 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs.

Barbara Denise Butler, 51, of Ladonia - pleaded guilty to the State Jail Felony offense of **MAN DEL CS PG 1 <1G**. Butler was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed a \$1,000 fine, \$329 court costs and \$180 restitution. Butler was referred to the Fannin County Drug Court program of intense but personalized supervision.

Barbara Denise Butler, 51, of Ladonia - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Butler was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed \$324 court costs and \$180 restitution. Butler was referred to the Fannin County Drug Court program of intense but personalized supervision.

Ester Marie Clark, 40, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **POSSESSION CS PG 1 >=1G<4G**. Clark was placed on Deferred Adjudication Community Supervision for a period of 8 years and assessed a \$1,000 fine, \$329 court costs and \$180 restitution. Clark was referred to the Fannin County Drug Court program of intense but personalized supervision.

Joseph Edward Dyson, 38, of Bonham - pleaded guilty to the State Jail Felony offense of **CREDIT CARD OR DEBIT CARD ABUSE**. Dyson was convicted and sentenced to serve a term of 6 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$254 court costs and \$133.59 restitution.

Dennis Dewayne Finney, 37, of Honey Grove - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **ASSAULT CAUSES BODILY INJURY FAMILY MEMBER**. Finney was placed on Deferred Adjudication Community Supervision for a period of 3 months and assessed \$254 court costs.

Debora Lynn Gregory, 48, of Bonham - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Gregory was convicted and sentenced to serve a term of 18 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$485 fine, \$279 court costs and \$725 restitution for the State Jail Felony offense of **THEFT OF PROPERTY \$500<\$1,500 ENH** committed on or about September 19, 2014.

Debora Lynn Gregory, 48, of Bonham - pleaded guilty to the State Jail Felony offense of **MAN DEL CS PG 1 <1G**. Gregory was convicted and sentenced to serve a term of 18 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$314 court costs and \$180 restitution.

Dawn Michelle Griffin, 45, of Trenton - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Griffin was placed on Deferred Adjudication Community Supervision for a period of 4 years and assessed a \$750 fine and \$329 court costs.

Lisa Annette Hamilton, 45, of Bonham - pleaded guilty to the State Jail Felony offense of **UNAUTHORIZED USE OF VEHICLE—ENHANCED**. Hamilton was convicted and sentenced to serve a term of 7 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs.

Lisa Annette Hamilton, 45, of Bonham - pleaded guilty to *three* State Jail Felony offenses of **FORGERY OF FINANCIAL INSTRUMENT—ENHANCED**. Hamilton was convicted and sentenced to serve a term of 7 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$762 court costs and \$845.10 restitution.

Chad Eric Hemphill, 42, of Bonham - pleaded guilty to *two* 2nd Degree Felony offenses of **MAN DEL CS PG 1 >=1G<4G—ENHANCED**. Hemphill was convicted and sentenced to serve a term of 13 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$628 court costs and \$360 restitution.

Michael Jason Hokanson, 32, of Savoy - pleaded guilty to the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED/OPEN ALCOHOL CONTAINER 3RD OR MORE**. Hokanson was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed \$314 court costs and \$100 restitution. After sentencing Hokanson, the court suspended his sentence and placed him on community supervision for a period of 10 years. As a condition of probation, Hokanson was sent to SAFPF.

Amanda Marie Holcomb, 48, of Sherman - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **Attempted THEFT OF PROPERTY >=\$2,500<\$30,000**. Holcomb was placed on Deferred Adjudication Community Supervision for a period of 2 years, assessed \$254 court costs and \$6,099.01 restitution. All restitution was paid prior to the plea.

Keynon Murrell Jones, 25, of Bonham - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Jones was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,500 fine, \$309 court costs and \$140 restitution for the 3rd Degree Felony offense of **POSSESSION CS PG 1 >=1G<4G** committed on or about June 15, 2014.

Keynon Murrell Jones, 25, of Bonham - pleaded guilty to the State Jail Felony offense of **MAN DEL CS PG 1 <1G**. Jones was convicted and sentenced to serve a term of 18 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$314 court costs and \$180 restitution.

Rachelle Blair Lehew, 32, of Bonham - pleaded guilty to the 2nd Degree Felony offense of **POSSESSION CS PG 1 >=4G<200G**. Lehew was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed a \$1,000 fine, \$314 court costs and \$180 restitution.

Jasmine Marie Lingelbach, 22, of Bonham - pleaded guilty to the State Jail Felony offense of **MAN DEL CS PG 1 <1G**. Lingelbach was placed on Deferred Adjudication Community Supervision for a period of 4 years and assessed a \$1,000 fine, \$314 court costs and \$180 restitution.

Dylan Lee Loftice, 23, of Whitewright - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Loftice was convicted and sentenced to serve a term of 9 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$675 fine, \$264 court costs and \$1,750 restitution for the State Jail Felony offense of **BURGLARY OF BUILDING** committed on or about December 29, 2010.

Dylan Lee Loftice, 23, of Whitewright - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Loftice was convicted and sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs for the 3rd Degree Felony offense of **ENGAGE IN ORGANIZED CRIMINAL ACTIVITY** committed on or about December 30, 2010.

David Dewayne Loftin, 41, of Pecan Gap - pleaded true to the allegations contained in the State's Motion to Revoke Community Supervision. Loftin was convicted and sentenced to serve a term of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$249 court costs for the 2nd Degree Felony offense of **BURGLARY OF HABITATION** committed on or about July 18, 2015.

Matthew Lee Lumpkins, 29, of Bonham - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Lumpkins was convicted and sentenced to serve a term of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division for the 3rd Degree Felony offense of **INJURY CHILD/ELDERLY/DISABLE W/INTENT BODILY INJURY** committed on or about November 17, 2010.

Ashley Martin, 29, of Dallas - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Martin was convicted and sentenced to serve a term of 24 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,000 fine, \$304 court costs and \$180 restitution for the State Jail Felony offense of **MAN DEL CS PG 1 <1G** committed on or about May 22, 2015.

Cody Michael-Doyle Moore, 23, of Blue Ridge - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Moore was convicted and sentenced to serve a term of 15 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,250 fine, \$274 court costs, and \$2,797.50 restitution for the State Jail Felony offense of **THEFT PROPERTY >=\$1,500<\$20,000** committed on or about May 13, 2012.

John Wesley Robinson, 28, of Durant - pleaded guilty to the State Jail Felony offense of **POSSESSION CS PG 1 <1G**. Robinson was placed on Deferred Adjudication Community Supervision for a period of 3 years and assessed a \$1,500 fine, \$329 court costs and \$180 restitution.

Chad Runnels, 37, of Sherman - pleaded guilty to the 3rd Degree Felony offense of **EVADING ARREST DETENTION W/VEHICLE**. Runnels was convicted and sentenced to a term of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$254 court costs.

Lapacus Dewayne Russell, 25, of Wolfe City - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. Russell was convicted and sentenced to serve a term of 18 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$5,000 fine and \$639 court costs for the 2nd Degree Felony offense of **SEXUAL ASSAULT CHILD** committed on or about November 12, 2010.

Jesse Aaron Shaw, 36, of Savoy - pleaded guilty to the 3rd Degree Felony offense of **DRIVING WHILE INTOXICATED 3RD OR MORE—ENHANCED**. Shaw was convicted and sentenced to a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division, assessed a \$1,500 fine, \$314 court costs and \$100 restitution. After sentencing Shaw, the court suspended his sentence and placed him on community supervision for a period of 10 years. As a condition of probation, Shaw was sent to SAFPF.

John Shuler, 38, of Greenville - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **TAMPER WITH GOVERNMENT RECORD**. Shuler was placed on Deferred Adjudication Community Supervision for a period of 2 years and assessed \$254 court costs.

Marcos Vasquez-Sandoval, 21, of Trenton - pleaded *NOT TRUE* to the allegations contained in the State's Motion to Adjudicate Guilt. After a hearing before Judge Laurine Blake of the 336th Judicial District Court, Vasquez-Sandoval was convicted and sentenced to serve a term of 10 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$2,000 fine, \$329 court costs, and \$140 restitution for the 3rd Degree Felony offense of **POSSESSION CS PG 1 <1G DRUG FREE ZONE** committed on or about January 29, 2014.

Stephanie Renea Vela, 22, of Melissa - pleaded guilty to two State Jail Felony offenses of **BURGLARY OF BUILDING**. Vela was convicted and sentenced to serve a term of 180 days incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,500 fine, \$638 court costs and \$445 restitution.

Misty Renee Walters, 39, of Paris - pleaded guilty to the State Jail Felony offense of **POSSESSION MARIJUANA >4OZ<=5LBS**. Walters was convicted and sentenced to a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division, assessed a \$1,500 fine and \$314 court costs. After sentencing Walters, the court suspended her sentence and placed her on community supervision for a period of 5 years.

Colby Ryan Whitson, 27, of Bonham - pleaded guilty to the 1st Degree Felony offense of **AGGRAVATED ROBBERY**. Whitson was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed a \$2,000 fine, \$314 court costs and \$453 restitution.
