Fannin County Grand Jury Concludes Year With a Total of 426 New Felony Cases Filed

Criminal District Attorney Richard Glaser reports that on Thursday, December 15, 2016, the Grand Jury met to review evidence in thirty-eight (38) cases presented for their consideration. The Grand Jury returned thirty-eight (38) true bills or indictments.

In addition, the Grand Jury was presented with a Petition on a juvenile case. Juvenile cases must be presented to the grand jury for acceptance when the State of Texas is seeking a determinate sentence. Determinate sentences occur in a limited number of juvenile cases that involve habitual offenders or violent crimes. A juvenile offender with a determinate sentence faces the possibility of transfer to the adult system if they are unsuccessful in rehabilitation efforts at the juvenile level.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
