

## **PRESS RELEASE**

### **Sex, Drugs and Defendants' Failure to Appear in Court Result in New Felony Charges**

Criminal District Attorney Richard Glaser reports that on Thursday, April 20, 2017, the Grand Jury met to review evidence in twenty-six (26) cases presented for their consideration. The Grand Jury returned twenty-three (23) true bills or indictments. The Fannin County Grand Jury has returned 103 true bills of indictment so far in 2017.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
