336th District Court Felony Dispositions for March, 2017

Richard Glaser, Criminal District Attorney, released a list of people who entered into plea agreements with his office during the March dockets before Judge Laurine Blake of the 336th District Court of Fannin County. The following individuals either entered guilty pleas and accepted responsibility for their conduct without further court action or their cases went to trial and a Fannin County Jury rendered the verdict and sentence indicated.

Jose Antonio Lugo-Agostadero, 39, of McKinney - pleaded guilty to the State Jail Felony offense of **DRIVING WHILE INTOXICATED W/CHILD UNDER 15 YOA**. LUGO-AGOSTADERO was convicted and sentenced to serve a term of 2 years incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$1,500 fine and \$329 court costs. After sentencing Lugo-Agostadero, the court suspended his sentence and placed him on community supervision for a period of 5 years.

Dorian Jamil Blair, Jr., 18, of Savoy - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **ASSAULT CAUSES BODILY INJURY FAMILY MEMBER**. BLAIR was placed on Deferred Adjudication Community Supervision for a period of 2 years, assessed a \$500 fine which was probated and \$304 court costs.

Wilmer Fernando Brito, 42, of Bonham – pleaded not guilty to the 1st Degree Felony Offense of **AGGRAVATED SEXUAL ASSAULT OF A CHILD**. BRITO was FOUND GUILTY BY A JURY and the court rendered a sentence of 30 years in the Texas Department of Criminal Justice – Institutional Division and he was assessed \$724 court costs.

Carleton Lee Coleman, 23, of Bonham - pleaded guilty to the *lesser included* 2nd Degree Felony offense of **ROBBERY**. COLEMAN was placed on Deferred Adjudication Community Supervision for a period of 10 years, assessed A \$1,000 fine and \$254 court costs.

Tammy Renee Erwin, 39, of Sherman - pleaded guilty to the 3rd Degree Felony offense of **PROHIBITED SUBSTANCE IN A CORRECTIONAL FACILITY—ALCOHOL/DRUGS/PHONE/TOBACCO**. ERWIN was convicted and sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$269 court costs.

Tammy Renee Erwin, 39, of Sherman - pleaded guilty to the 3rd Degree Felony offense of **BAIL JUMPING AND FAIL TO APPEAR FELONY**. ERWIN was convicted and sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$304 court costs.

Jacquylin Paige Garza, 19, of Bonham - pleaded true to the allegations contained in the State's Motion to Adjudicate Guilt. GARZA was convicted and sentenced to serve a term of 12 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed a \$500 fine and \$254 court costs for the State Jail Felony offense of **UNAUTHORIZED USE OF A VEHICLE** committed on or about December 29, 2014.

Earl Wayne Gattis, 50, of Frankston - pleaded guilty to the State Jail Felony offense of **POSS (POSSESSION) CS (CONTROLLED SUBSTANCE) PG (PENALTY GROUP) 1 <1G (LESS THAN 1 GRAM)**. GATTIS was placed on Deferred Adjudication Community Supervision for a period of 3 years and assessed \$314 court costs and \$180 restitution. Gattis was referred to the Fannin County Drug Court program of intense but personalized supervision.

Rebecca Dawn Gonzalez, 40, of Bonham - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **ASSAULT CAUSES BODILY INJURY**. GONZALEZ was placed on Deferred Adjudication Community Supervision for a period of 2 years, assessed a \$1,000 (which was probated) and \$269 court costs.

Jontay Grisby, 24, of Honey Grove - pleaded guilty to the 3rd Degree Felony offense of **SEX OFFENDERS DUTY TO REGISTER LIFE/ANNUALLY**. GRISBY was convicted and sentenced to serve a term of 4 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$254 court costs. After sentencing Grisby, the court suspended his sentence and placed him on community supervision for a period of 4 years.

Mark Fenton Hodges, 61, Inmate - pleaded guilty to the 3rd Degree Felony offense of **HARASSMENT BY PERSON IN CORRECTIONAL/DENTENTION**. HODGES was convicted and sentenced to serve a term of 2 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$254 court costs.

James King, 47, of Sherman - pleaded true to the allegations contained in the State's Motion Revoking Community Supervision. KING was convicted and sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$249 court costs for the 3rd Degree Felony offense of **UNLAWFUL POSSESSION OF FIREARM BY FELON** committed on or about March 22, 2014.

James King, 47, of Sherman - pleaded true to the allegations contained in the State's Motion Revoking Community Supervision. KING was convicted and sentenced to serve a term of 15 months incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$309 court costs for the State Jail Felony offense of **POSS CS PG 1 <1G** committed on or about March 22, 2014.

James Lane Kreitel, 51, Bonham - pleaded guilty to the 3rd Degree Felony offense of **MAN DEL CS PG 1 <1G DRUG FREE ZONE—ENHANCED**. KREITEL was convicted and sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$329 court costs and \$180 restitution.

James Lane Kreitel, 51, Bonham - pleaded guilty to the 3rd Degree Felony offense of **POSS CS PG 1 <1G DRUG FREE ZONE IAT**. KREITEL was convicted and sentenced to serve a term of 3 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$329 court costs and \$180 restitution.

Rachelle Blair Lehew, 23, Bonham - pleaded guilty to the 2nd Degree Felony offense of **POSS CS PG 1 >=4G<200G**. BLAIR was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,000 fine, \$314 court costs and \$180 restitution.

Nickey Lynn Montgomery, 34, of Sherman - pleaded guilty to the *lesser included* 3rd Degree Felony offense of **POSS CS PG 1 >=1G<4G**. MONTGOMERY was placed on Deferred Adjudication Community Supervision for a period of 10 years, assessed a \$2,000 fine, \$314 court costs, and \$180 restitution. As a condition of probation, Montgomery was sent to SAFPF.

Nickey Lynn Montgomery, 34, of Sherman - pleaded guilty to the 3rd Degree Felony offense of **MAN DEL CS PG 1 <1G DRUG FREE ZONE**. MONTGOMERY was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed \$314 court costs and \$180 restitution. As a condition of probation, Montgomery was sent to SAFPF.

Nickey Lynn Montgomery, 34, of Sherman - pleaded guilty to the State Jail Felony offense of **MAN DEL CS PG 1 <1G**. MONTGOMERY was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed \$314 court costs. As a condition of probation, Montgomery was sent to SAFPF.

SAFPF (Substance Abuse Felony Punishment Facility) is an intensive 6-9 month program in a SAFPF Unit for offenders who are sentenced by the Judge who are chemically dependent as shown by an accepted substance abuse screening instrument. Offenders who successfully complete the unit program must transition to an approved Texas Department of Criminal Justice residential facility, or, if they have a good home plan, they are released to the 4C program. From there, they start a supportive outpatient program that is approved by TDCJ.

Richard Dean Moore, II, 26, of Bonham - pleaded guilty to the 2nd Degree Felony offense of **MAN DEL CS PG 1 >=1G<4G**. MOORE was placed on Deferred Adjudication Community Supervision for a period of 10 years, assessed a \$1,500 fine, \$379 court costs, and \$180 restitution. As a condition of probation, Moore was sent to SAFPF.

Richard Dean Moore, II, 26, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **POSS CS PG 1 >=1G<4G DRUG FREE ZONE**. MOORE was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed \$324 court costs and \$180 restitution. As a condition of probation, Moore was sent to SAFPF.

Paul Lynn Murphy, 32, of Leonard - pleaded guilty to the 2nd Degree Felony offense of **AGGRAVATED ASSAULT W/DEADLY WEAPON**. MURPHY was placed on Deferred Adjudication Community Supervision for a period of 10 years, assessed a \$500 fine, \$294 court costs, and \$1,280 restitution.

Paul Lynn Murphy, 32, of Leonard - pleaded guilty to the 3rd Degree Felony offense of **STALKING**. MURPHY was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed \$294 court costs.

Michael Jireh Ocanas, 20, of Savoy - pleaded guilty to the State Jail Felony offense of **UNAUTHORIZED USE OF A MOTOR VEHICLE**. OCANAS was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed a \$750 fine and \$319 court costs.

Michael Jireh Ocanas, 20, of Savoy - pleaded guilty to the State Jail Felony offense of **POSS MARIJUANA >4OZ<=5LBS**. OCANAS was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed \$379 court costs and \$180 restitution. Ocanas was referred to the Fannin County Drug Court program of intense but personalized supervision.

Michael Scott Parchem, 31, of Denison - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **POSS CS PG 1 <1G**. PARCHEM was placed on Deferred Adjudication Community Supervision for a period of 2 years and assessed a \$4,000 fine, \$329 court costs and \$180 restitution.

Amy Lynn Pender, 29, of Bonham - pleaded guilty to the 2nd Degree Felony offense of **AGGRAVATED ASSAULT W/DEADLY WEAPON**. PENDER was placed on Deferred Adjudication Community Supervision for a period of 5 years and assessed a \$2,000 fine and \$264 court costs.

Theodore Roskowske, 66, of Honey Grove - pleaded guilty to the 3rd Degree Felony offense of **ASSAULT FAMILY/HOUSEHOLD MEMBER W/PREVIOUS CONVICTION—ENHANCED**. ROSKOWSKE was placed on Deferred Adjudication Community Supervision for a period of 10 years and assessed a \$1,500 fine and \$364 court costs. Roskowske was referred to the Fannin County Drug Court program of intense but personalized supervision.

Paul Sanders, 38, of Bonham - pleaded guilty to the 3rd Degree Felony offense of **ASSAULT FAMILY/HOUSEHOLD MEMBER W/PREVIOUS CONVICTION—ENHANCED**. SANDERS was placed on Deferred Adjudication Community Supervision for a period of 6 years and assessed a \$2,000 fine and \$314 court costs.

Steven Alan Stuber, 33, of Beaumont - pleaded guilty to the 3rd Degree Felony offense of **SEX OFFENDERS DUTY TO REGISTER LIFE/ANNUALLY**. STUBER was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,000 fine and \$254 court costs. After sentencing Stuber, the court suspended his sentence and placed him on community supervision for a period of 5 years.

Joshua Taylor, 29, of Bonham – pleaded not guilty to the 3rd Degree Felony Offense of **ASSAULT BODILY INJURY FAMILY/HOUSE MEMBER 2+ W/IN 12 MONTHS**. TAYLOR was FOUND GUILTY BY A JURY and that same jury rendered a sentence of 10 years in the Texas Department of Criminal Justice – Institutional Division and he was assessed a \$7,500 fine and \$349 court costs. After sentencing Taylor, the jury suspended his sentence and placed him on community supervision for a period of 10 years. As a condition of probation, Taylor was sent to SAFFP.

Joshua Taylor, 29, of Bonham – pleaded not guilty to the 3rd Degree Felony Offense of **ASSAULT FAMILY/HOUSEHOLD MEMBER W/PREVIOUS CONVICTION**. TAYLOR was FOUND NOT GUILTY BY A JURY.

Tyson Ray Thomas, 27, of Bonham - pleaded true to the allegations contained in the State's Motion Adjudicating Guilt. THOMAS was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed a \$1,965 fine and \$319 court costs for the 3rd Degree Felony offense of **POSS MARIJUANA >4OZ<=5LBS DRUG FREE ZONE** committed on or about May 15, 2013.

Tyson Ray Thomas, 27, of Bonham - pleaded guilty to 2nd Degree Felony offense of **MAN DEL CS PG 1 >=1G<4G**. THOMAS was convicted and sentenced to serve a term of 5 years incarceration in the Texas Department of Criminal Justice – Institutional Division and assessed \$314 court costs and \$180 restitution.

Tyson Ray Thomas, 27, of Bonham - pleaded guilty to State Jail Felony offense of **ABANDON ENDANGER CHILD CRIMINAL NEGLIGENCE**. THOMAS was convicted and sentenced to serve a term of 1 year incarceration in the Texas Department of Criminal Justice – State Jail Division and assessed \$254 court costs.

Cody Bryant Wegley, 20, of Bonham - pleaded guilty to the *lesser included* Class A Misdemeanor offense of **ASSAULT CAUSES BODILY INJURY**. WEGLEY was placed on Deferred Adjudication Community Supervision for a period of 1 year, assessed a \$750 fine and \$369 court costs.
