

## **PRESS RELEASE**

### **Theft Charges Increase and More Drugs**

Criminal District Attorney Richard Glaser reports that on Thursday, March 16, 2017, the Grand Jury met to review evidence in twenty-eight (28) cases presented for their consideration. The Grand Jury returned twenty-six (26) true bills or indictments. Two cases were passed for further action next session. The Fannin County Grand Jury has returned 80 true bills of indictment so far in 2017.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
