

## PRESS RELEASE

### Drugs and DWIs Dominate Fannin County Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, October 19, 2017, the Grand Jury met to review evidence in twenty-eight (28) cases presented for their consideration. The Grand Jury returned twenty-seven (27) true bills or indictments listed below. One (1) case was passed for further action next session. Drugs and DWI charges accounted for almost half of the new felony charges filed. The Fannin County Grand Jury has returned 262 true bills of indictment so far in 2017.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
