Fannin County Citizens Hear About Assaults and More Drugs on the Street During Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, February 22, 2018, the Grand Jury met to review evidence in fifty-two (52) cases presented for their consideration. The Grand Jury returned forty-eight (48) true bills or indictments. Three cases were passed for further action next session and one case was no billed. The Fannin County Grand Jury has returned 67 true bills of indictment so far in 2018.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
