Violence Rises in Fannin County as Assault Charges Increase

Criminal District Attorney Richard Glaser reports that on Thursday, March 22, 2018, the Grand Jury met to review evidence in fourteen (14) cases presented for their consideration. The Grand Jury no billed one (1) case and returned thirteen (13) true bills or indictments. In addition, there were eight (8) violence cases in February. The Fannin County Grand Jury has returned 80 true bills of indictment so far in 2018.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
