Theft Ring Activity and Drug Charges Greets New Grand Jury

Criminal District Attorney Richard Glaser reports that on Thursday, July 19, 2018, the newly impaneled Grand Jury for the July Term convened for their first formal session. At that initial session and after some brief instructions in the workings of a Grand Jury, twenty-two (22) cases were presented resulting in twenty-one (21) True Bills of indictment. One (1) case was passed for further information. So far in 2018, a total of 174 cases have been charged in Fannin County.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
