Fannin County Grand Jury Concludes Year With a Total of 298 New Felony Cases Filed

Criminal District Attorney Richard Glaser reports that on Thursday, December 20, 2018, the Grand Jury met to review evidence in thirty-seven (37) cases presented for their consideration. The Grand Jury returned thirty-six (36) true bills or indictments. One case was passed in order to give the witness time to appear.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
