Fannin County Citizens Hear About Thefts and More Drugs on the Street During Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, February 21, 2019, the Grand Jury met to review evidence in thirty-six (36) cases presented for their consideration. The Grand Jury returned thirty-six (36) true bills or indictments. The Fannin County Grand Jury has returned 67 true bills of indictment so far in 2019.

The Grand Jury also heard and considered evidence in a custodial shooting incident. The incident was investigated by the Texas Rangers. After hearing the evidence, the Grand Jury decided that no further action was needed.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
