Fannin County Citizens Hear About Drugs, Fraud and Theft During Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, March 21, 2019, the Grand Jury met to consider twenty-eight (28) cases. Twenty-eight (28) cases were True Billed or indicted and filed with the District Clerk. The Fannin County Grand Jury has returned 95 true bills of indictment so far in 2019.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
