**Fannin County Citizens Hear Multiple Child Pornography
and Drug Charges During Grand Jury Session**

Criminal District Attorney Richard Glaser reports that on Tuesday, May 21, 2019, the Grand Jury met in a lengthy session to review evidence in thirty-three (33) cases presented for their consideration. The Grand Jury returned thirty-two (32) true bills or indictments listed below and one (1) No Bill. The Fannin County Grand Jury has returned 140 true bills of indictment so far in 2019.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
