## Fannin County Grand Jury Hears Multiple Assault, Theft and Drug Cases

Criminal District Attorney Richard Glaser reports that on Thursday, August 22, 2019, the Grand Jury met to review thirty-six (36) cases presented for their consideration. The Grand Jury returned thirty-six (36) true bills or indictments listed below. The Fannin County Grand Jury has returned 221 true bills of indictment so far in 2019.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
