Grand Jury Hears Fraud and Forgery Charges

Criminal District Attorney Richard Glaser reports that the Fannin County Grand Jury heard fifteen (15) cases presented for its consideration during their November 21 session. Fifteen (15) cases were true billed and indictments filed with the District Clerk, Nancy Young. Once filed, those cases will be promptly scheduled for a first appearance before Judge Laurine Blake of the 336th District Court. The Fannin County Grand Jury has returned 258 true bills of indictment so far in 2019.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
