Fannin County Grand Jury Concludes Year With a Total of 276 New Felony Cases Filed

Criminal District Attorney Richard Glaser reports that the Fannin County Grand Jury heard eighteen (18) cases presented for its consideration during their December 19 session. Eighteen (18) cases were true billed and indictments filed with the District Clerk. One-half of those cases presented were drug or alcohol related.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
