Grand Jury Proceedings Have Been Deemed Essential Proceedings

Criminal District Attorney Richard Glaser reports that on Thursday, April 23, 2020, the Grand Jury met and considered a plethora of cases filed with the Criminal District Attorney's Office by Fannin County law enforcement agencies. The Grand Jury returned seventy-six (76) true bills or indictments listed below. The Fannin County Grand Jury has returned 113 true bills of indictment so far in 2020.

Special arrangements were made for the safety of the Grand Jurors as well as the other participants. The usual Grand Jury "room" provided by Fannin County did not provide enough separated space consistent with social distancing. District Judge Laurine Blake relinquished her courtroom so that sufficient space allowed for those involved to be separated for social distancing. Judge Blake also provided face coverings for those participants who needed them. Because of the unusually large number of cases to be considered, lunch was provided.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
