Grand Jury Hears Multiple Drug and Assault Charges

Criminal District Attorney Richard Glaser reports that on Thursday, October 22, 2020, the Grand Jury met and reviewed evidence in sixty-three (63) cases. This Grand Jury returned sixty (60) true bills or indictments listed below. Three cases were no billed. The Fannin County Grand Jury has returned 521 true bills of indictment so far in 2020.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
