Grand Jury Hears Record Number of Cases

Criminal District Attorney Richard Glaser reports that on Thursday, August 20, 2020, the Grand Jury met to review evidence in one hundred eight (108) cases presented for their consideration. The Grand Jury returned one hundred eight (108) true bills or indictments. The Fannin County Grand Jury has returned 358 true bills of indictment so far in 2020.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
