Newly Impaneled Grand Jury Hears Cases

On Thursday, January 21, 2021, the newly impaneled Grand Jury for Fannin County met for its first session. At that time, the Criminal District Attorney's Office presented thirty-one (31) cases for their review. Thirty (30) cases were True Billed and one (1) case was passed for further action next session.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
