## Grand Jury Hears Multiple Assault and Drug Charges

Criminal District Attorney Richard Glaser reports that on Thursday, March 18, 2021, the Grand Jury met to review evidence in sixty-seven (67) cases presented for their consideration. The Grand Jury returned sixty-six (66) true bills or indictments. One case was passed for further information. These cases were a combination of the months of February and March as the severe weather necessitated cancelling Grand Jury in February. The Fannin County Grand Jury has returned 96 true bills of indictment so far in 2021.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
