### Fannin County Citizens Hear Multiple Assault and Drug Charges During Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, May 20, 2021, the Grand Jury met to review evidence in thirty-three (33) cases presented for their consideration. The Grand Jury returned thirty-three (33) true bills or indictments. The Fannin County Grand Jury has returned 174 true bills of indictment so far in 2021.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
