Grand Jury Hears Multiple Theft and Forgery Charges

Criminal District Attorney Richard Glaser reports that on Thursday, October 21, 2021, the Grand Jury met and reviewed evidence in sixty-one (61) cases. This Grand Jury returned sixty (60) true bills or indictments listed below; one case was no billed. The Fannin County Grand Jury has returned 313 true bills of indictment so far in 2021.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
