### Newly Impaneled Grand Jury Hears Cases

On Thursday, January 20, 2022, the newly impaneled Grand Jury for Fannin County met for its first session. At that time, the Criminal District Attorney's Office presented fifteen (15) cases for their review. Twelve (12) cases were True Billed and three (3) cases were passed for further action next session.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
