Drug Charges and Sexual Assault Cases Greet New Grand Jury

Criminal District Attorney Richard Glaser reports that on Thursday, July 21, the newly impaneled Grand Jury for the July Term convened for their first formal session. At that initial session and after some brief instructions in the workings of a Grand Jury, twenty-three (23) cases were presented for their consideration. The Grand Jury returned twenty-three (23) true bills or indictments. So far in 2022, a total of 172 cases have been charged in Fannin County.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
