Drug Cases Prevail at Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, September 22, 2022, the Grand Jury met to review twenty-eight (28) cases presented for their consideration. The Grand Jury returned twenty-seven (27) true bills or indictments listed below. One (1) case was passed for further information. The Fannin County Grand Jury has returned 234 true bills of indictment so far in 2022.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
