### Grand Jury Hears Multiple Drug Charges

Criminal District Attorney Richard Glaser reports that the Fannin County Grand Jury heard nineteen (19) cases presented for its consideration during their November 17 session. Nineteen (19) cases were true billed and indictments filed with the District Clerk. The Fannin County Grand Jury has returned 284 true bills of indictment so far in 2022.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
