### **Fannin County Grand Jury Concludes Year With With a Total of 311 New Cases**

Criminal District Attorney Richard Glaser reports that on Thursday, December 15, 2022, the Grand Jury met and reviewed evidence in twenty-seven (27) cases. This Grand Jury returned twenty-seven (27) true bills or indictments listed below. The Fannin County Grand Jury has returned 311 true bills of indictment in 2022.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
