Fannin County Grand Jury Hears About Perjury, Drug and Assault Charges

Criminal District Attorney Richard Glaser reports that on Thursday, February 23, 2023, the Grand Jury met and reviewed evidence in thirty-four (34) cases. This Grand Jury returned thirty-three (33) true bills or indictments, and one (1) case was No Billed. The Fannin County Grand Jury has returned 50 true bills of indictment in 2023.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
