DWIs and Drugs Result in New Felony Charges

Criminal District Attorney Richard Glaser reports that on Thursday, March 23, 2023, the Grand Jury met to review evidence in ten (10) cases presented for their consideration. The Grand Jury returned nine (9) true bills or indictments and one (1) case was no billed. The Fannin County Grand Jury has returned 59 true bills of indictment so far in 2023.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
