Assaults and Drugs Result in New Felony Charges

Criminal District Attorney Richard Glaser reports that on Thursday, April 20, 2023, the Grand Jury met to review evidence in nineteen (19) cases presented for their consideration. The Grand Jury returned fifteen (15) true bills or indictments. One (1) case was No Billed and three (3) cases were passed for further information. The Fannin County Grand Jury has returned 74 true bills of indictment so far in 2023.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
