### Fannin County Citizens Hear Child Pornography Charges During Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, May 18, 2023, the Grand Jury met to review evidence in seventeen (17) cases presented for their consideration. The Grand Jury returned sixteen (16) true bills or indictments, and one (1) case was no billed. The Fannin County Grand Jury has returned 90 true bills of indictment so far in 2022.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
