### Grand Jury Hears Multiple Drug Charges and Assault Charges

Criminal District Attorney Richard Glaser reports that on Thursday, June 22, 2023, the current Grand Jury met in its final session and reviewed evidence in eighteen (18) cases. This Grand Jury returned eighteen (18) true bills or indictments listed below. The Fannin County Grand Jury has returned 133 true bills of indictment so far in 2023.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
