Fannin County Grand Jury Hears Even Mix of Alcohol/Drugs/Assault Cases

Criminal District Attorney Richard Glaser reports that on Thursday, August 24, 2023, the Grand Jury met to review forty-three (43) cases presented for their consideration. The Grand Jury returned forty-three (43) true bills or indictments listed below. The Fannin County Grand Jury has returned 176 true bills of indictment so far in 2023.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
