Drug Cases Prevail at Grand Jury Session

Criminal District Attorney Richard Glaser reports that on Thursday, September 21, 2023, the Grand Jury met to review seventeen (17) cases presented for their consideration. The Grand Jury returned seventeen (17) true bills or indictments listed below. The Fannin County Grand Jury has returned 193 true bills of indictment so far in 2023.

The Grand Jury also heard and considered evidence in an officer involved shooting incident. The incident was investigated by the Texas Rangers. Finding the use of force justified, the Grand Jury declined any charges against the officers involved.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
