Grand Jury Hears Assault Charges

Criminal District Attorney Richard Glaser reports that the Fannin County Grand Jury heard fourteen (14) cases presented for its consideration during their November 16 session. Twelve (12) cases were true billed and two (2) cases were passed for further information. The Fannin County Grand Jury has returned 242 true bills of indictment so far in 2023.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
