Fannin County Grand Jury Hears About Escape, Assault and Drug Charges

Criminal District Attorney Richard Glaser reports that on Thursday, February 22, 2024, the Grand Jury met and reviewed evidence in thirty-one (31) cases. This Grand Jury returned thirty (30) true bills or indictments, and one (1) case was passed for further information. The Fannin County Grand Jury has returned 43 true bills of indictment in 2024.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
