

## PRESS RELEASE

### **DWI's and Bail Jumping Charges Presented to Grand Jury**

Criminal District Attorney Richard Glaser reports that on Thursday, March 21, 2024, the Grand Jury met and reviewed evidence in thirty-three (33) cases and the Grand Jury returned thirty (30) true bills or indictments listed below. Two (2) cases were No Billed and one (1) case was passed for further information. The Fannin County Grand Jury has returned 73 true bills of indictment so far in 2024.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
